The project is running smoothly. The cafeteria project is still on track. The Mobile Modular will be wired for electricity by the end of the week. The electricity was out on 6/25 and 6/26 due to a PG&E outage. The larger playground is waiting for ESSER approval. Mayra Sanchez commented that we are looking into ESSER funds submitted the application mid-May, it takes 6 weeks for approval. The ELOP/charter money may be used towards the project if unapproved. The playground clean-up and the new shade structure is up and almost finished.

Last week, upper grade went to Great America while lower grade went to Fresno State’s Planetarium and enjoyed Ampersand Ice Cream and the bubble guy.
